Thematic Outline

The cp³ project conducted three-year research on collaborative governance arrangements as innovative approaches in policy to enhance biodiversity and ecosystem services in agricultural landscapes. Thereby, collaborative governance builds upon partnerships of actors from the civil society, public and private sphere of society and is contrasted to hierarchical command and control or market-based governance approaches. The analysis was based on empirical research in three European protection areas: the Biosphere reserve Spreewald, Germany, the Nature park Jauerling-Wachau, Austria, and the Berg en Dal region as part of the National Landscape Gelderse Poort, Netherlands.

The workshops will focus on the following topics:

- Relevance of collaborative governance approaches in Germany and in the European Union in comparison to hierarchical and market-based approaches
- Preconditions for the successful emergence of collaborative governance approaches with respect to the political frame conditions

After a short presentation of the project and the introduction of all participants, the different stations of the World Café are advertised. In the first round of the World Café, participants are introduced to the different collaborative governance approaches in the cp³ case study regions. In the second round, invited guest speakers present further innovative projects and approaches for collaborative governance in Europe. The workshop continues with group work to deepen the workshop topics, a presentation of the group work to the plenum and a final discussion. The workshop closes with the opportunity for the participants to watch a movie on the Austrian case study while enjoying a small buffet with local produce from the different case study regions.
